## TRADEMARK SECURITY AGREEMENT (SUBSIDIARY)

THIS TRADEMARK SECURITY AGREEMENT ("Agreement") is between ANACS, LLC (the "Subsidiary"), and BANK OF AMERICA, N.A. NOW, THEREFORE, to secure the payment and performance of, among other things, the obligations of the Subsidiary under that certain Subsidiary Guaranty dated as of even date herewith (as amended, modified or supplemented from time to time) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Subsidiary hereby grants to the Secured Party a lien and continuing security interest in all of the Subsidiary's right, title, and interest in, to, and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether presently existing or hereafter created or acquired:

- (1) each trademark, trademark registration ("<u>Trademark Registration</u>") and trademark application ("<u>Trademark Application</u>"), including, without limitation, each trademark, Trademark Registration and Trademark Application referred to in <u>Schedule 1</u> annexed hereto, together with the goodwill of the business symbolized thereby; and


