RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, The Hobart West Group, Inc., a Delaware corporation, Hobart West Solutions, LLC, a Delaware limited liability company, Esquire Solutions, LLC, a Delaware limited liability company, Esquire Deposition Services, LLC, a Delaware limited liability company, Deponet, LLC, a Delaware limited liability company and Esquire Litigation Solutions, LLC, a Delaware limited liability company (each a "Debtor" and collectively, "Debtors"), each with its principal place of business at 25A Vreeland Rd., Florham Park, New Jersey 07932, granted a security interest in and lien upon certain trademarks and related rights to Union Bank of California, N.A., as collateral agent for certain lenders ("Secured Party") as set forth in the Security Agreement, dated as of June 24, 2003, by Debtors in favor of Secured Party (the "Security Agreement");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office on July 7, 2003 at Reel 002773, Frame 0371;

WHEREAS, Debtors have requested that Secured Party release and reassign its interest in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to each Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtors to Secured Party pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
