**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of May 31, 2006, from Citicorp USA, Inc., a Delaware corporation, with its principal place of business located at 153 East 53rd Street, New York NY 10043, as lender (the "Lender") to Chatam International Incorporated, a Delaware corporation and Charles Jacquin et Cie., a Pennsylvania corporation (collectively and individually referred to as "Borrower").

WITNESSETH:

WHEREAS, pursuant to the Amended and Restated Trademark Security Agreement, dated as of May 15, 2001, among the Lender, the Borrower and Greenberg Traurig, LLP, as escrow agent (the "Security Agreement"), the Borrower granted a security interest (the "Security Interest") to the Lender specifically in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 20, 2001, at Reel 2316 and Frame 0461; and

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby states as follows:

1. Definitions. The term "Trademark Collateral" as used herein, shall mean all of the Borrower's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Security Agreement.

2. Release of Security Interest. The Lender hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Lender in such Trademark Collateral shall hereby cease and become void.


3. Further Assurances. The Lender hereby agrees, at Borrower's sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
