RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (the "Release") is made as of this 30th day of June, 2006, by JPMorgan Chase Bank, N.A., a national banking institution, as successor in interest to NBD Bank, a Michigan Banking Corporation, and Bank One, N.A., a National Banking Association, as agent for certain lenders ("Bank") pursuant to a Security Agreement dated January 2, 1998 (NBD Bank) and an Amended and Restated Security Agreement dated December 7, 1999 (Bank One, N.A.) (the "Credit Agreements") in favor of MSX International, Inc., a Delaware corporation ("Borrower"), and certain of its Subsidiaries (each a "Loan Party" and collectively, the "Loan Parties").

WHEREAS, Borrower owns the patents and patent applications, the trademark registrations and applications, and the copyright registrations, listed on Exhibit A attached hereto and made a part hereof (the "Secured Collateral")

WHEREAS, pursuant to the Credit Agreements, Loan Parties made that certain Security Agreements (Patents), that certain Security Agreements (Trademarks), and that certain Security Agreement (Copyrights), each dated January 2, 1998 and December 7, 1999 (collectively, the "Security Agreements") in favor of Bank;

WHEREAS, the 1998 Security Agreement (Patents) with NBD Bank was recorded in the United States Patent and Trademark Office on April 3, 1998 at reel 9089 frame 0258;

WHEREAS, the 1998 Security Agreement (Trademarks) with NBD Bank was recorded in the United States Patent and Trademark Office on April 3, 1998 at reel 1714, frame 0001;

WHEREAS, the 1999 Security Agreement (Patents) with Bank One, N.A. was recorded in the United States Patent and Trademark Office on August 11, 2000 at reel 11058, frame 0466 and at reel 11027, frame 0239;

WHEREAS, the 1999 Security Agreement (Trademarks) with Bank One, N.A. was recorded in the United States Patent and Trademark Office on August 11, 2000, at reel 2138, frame 0700 and reel 2138, frame 0969;

WHEREAS, the 1999 Security Agreement (Copyrights) with Bank One, N.A. was recorded in the United States Copyright Office on August 11, 2000, at Volume 3457, page 68; and

WHEREAS, pursuant to the Security Agreements, Loan Parties granted to Bank a continuing security interest in its right, title and interest in and to the Secured Collateral to secure the prompt payment, performance and observance of certain obligations of Loan Parties to Bank as set forth in the Security Agreements .

WHEREAS, the Obligations have been discharged; and

WHEREAS, the Bank desires to release the Security Agreements.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which is hereby acknowledged, Bank, in its capacity as agent for the Lenders (as defined in the Credit Agreement), hereby unconditionally and expressly releases and terminates its security interest in and to the Secured Collateral, and Bank hereby assigns any such right, title and interest it may have in the Secured Collateral (if any) to Loan Parties. Bank further agrees to execute and deliver to Loan Parties any and all further documents or instruments and do any and all further acts which Loan Parties reasonably request in order to confirm this Release. This Release shall be binding upon Bank's legal representatives, assigns and successors.

IN WITNESS WHEREOF, Bank has caused this Release of Security Interest to be duly executed by its officer thereunto duly authorized as of the 30th day of June, 2006.
