SECURITY INTEREST IN TRADEMARKS


Reference is made to that certain Agreement, dated as of August 17, 2001 (the "Agreement") and recorded at the United States Patent and Trademark Office at Reel 2365 and Frame 0143 on September 6, 2001, by ZILA PHARMACEUTICALS, INC., a Nevada corporation (the "Grantor"), in favor of CONGRESS FINANCIAL CORPORATION (WESTERN), a California corporation ("Congress").
