ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS made as of the 30th day of June, 2006, by Day International, Inc., a Delaware corporation ("Assignor") to Aktiengesellschaft Adolph Saurer, a stock corporation organized under the laws of Switzerland ("Assignee").

RECITALS:

WHEREAS, pursuant to that certain Purchase Agreement dated as of May 9, 2006 (the "Purchase Agreement") by and among Day International Group, Inc., a Delaware corporation, Day Germany Holdings GmbH, a limited liability company organized under the laws of Germany, Saurer AG, Arbon, a stock corporation organized under the laws of Switzerland, Saurer GmbH & Co. KG, a limited partnership organized under the laws of Germany, Accotex Inc. (formerly known as ATPG International, Inc.), a South Carolina corporation, Assignor and Assignee, Assignor has agreed to sell to Assignee and Assignee has agreed to buy from Assignor the Purchased Intellectual Property (as defined in the Purchase Agreement), including without limitation the service marks, trademarks, trade names and domain names of Assignor. Pursuant to the Purchase Agreement, Assignor has agreed to execute such instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of, all of such assets.

WHEREAS, in accordance therewith, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under Assignor's registered and unregistered domestic and foreign service marks, trademarks, service mark and trademark applications, trade names and domain names, including without limitation the service marks, trademarks, service mark and trademark applications, trade names and domain names listed on Schedule A annexed hereto and incorporated herein by reference (all of the foregoing being referred to herein as the "Marks").

NOW, THEREFORE, Assignor, for and in exchange for the payment of the purchase price set forth in the Purchase Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Marks, and all the rights appurtenant thereto, together with the goodwill of the business associated therewith and which is symbolized thereby, all common law rights, all rights to sue for any past infringement or unauthorized use of any Mark and to recover all damages therefrom for its own use and behalf and for the use and behalf of its successors and assigns or other legal representatives, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Trademarks not been made.

Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request and expense of Assignee which Assignee may require in order to transfer all of Assignor's right, title and interest in and to the Marks to Assignee, its successors or assigns.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademarks shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the principles of conflicts of laws thereof.
