TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 31, 2006, by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent ("Agent").

WITNESSETH:

WHEREAS, Kranson Industries, Inc., a Missouri corporation ("Borrower"), and Smith Container Corporation, a Georgia corporation ("Smith"; Borrower and Smith are referred to herein each individually as a "Pledgor" and together as the "Pledgors") previously executed and delivered that certain Trademark Security Agreement dated as of July 30, 2004 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which each Pledgor granted a security interest to Agent in, and a collateral assignment to Agent of, among other things, the Released Trademarks (as such term is defined below) as security for certain obligations owing by Pledgors and certain of their affiliates to the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement dated as of July 30, 2004, as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, by and among Borrower, certain affiliate of the Borrower, Agent and the Lenders; and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 13, 2004, at Reel 3031, Frame 0515; and

WHEREAS, Pledgors have requested that Agent release its security interest in the Released Trademarks and reassign the same to Pledgors.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged:

1. Agent hereby releases its security interest in all of Pledgors' right, title and interest in and to all of the following:


- (a) all Trademarks of such Pledgor listed on Schedule I attached hereto (collectively, the "Released Trademarks");
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

2. Agent hereby reassigns, grants and conveys to Pledgors, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Released Trademarks, and the goodwill of Pledgors' business connected with the use of and symbolized by the Released Trademarks.
