RELEASE OF TRADEMARK SECURITY AGREEMENT SUPPLEMENT

This Release of Trademark Security Agreement Supplement dated as of July 31, 2006 ("Release"), is made by Bank of America, N.A., in its capacity as administrative agent under the Amended and Restated Credit Agreement dated as of August 17, 2005, among Power Well Services, Inc., as the borrower, the guarantors party thereto, including Debtor, Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent) and L/C issuer, and the other agents and lenders from time to time party thereto, as the same may be amended, restated, or otherwise modified from time to time (the "Credit Agreement") in favor of Power Well Services, Inc., a Delaware corporation ("Debtor").

RECITALS

WHEREAS, Administrative Agent and Debtor previously entered into that certain Trademark Security Agreement Supplement dated August 17, 2005, recorded in the United States Patent and Trademark Office on September 1, 2005 at Reel 003151, Frame 0848 (the "Security Agreement Supplement"), pursuant to which Administrative Agent purportedly owns a security interest in, among other things, Debtor's Trademarks (as defined in the Security Agreement Supplement), including those registered U.S. Trademark Applications and Registrations of the Debtor associated with such Security Agreement Supplement that are listed in the attached Exhibit A.

WHEREAS, the Administrative Agent desires to release its security interest in the registered U.S. Trademark Applications and Registrations listed in the attached Exhibit A.

NOW, THEREFORE, subject to the terms, conditions, covenants and provisions of this Release, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

Administrative Agent hereby releases all liens, security interests, assignments, and other interests of Administrative Agent in the Collateral (as defined in the Security Agreement Supplement), including, without limitation, the security interest in those U.S. Trademark Applications and Registrations listed in Exhibit A, which is attached hereto.
