**RELEASE OF SECURITY INTEREST -- TRADEMARKS**

WHEREAS, BNP Paribas ("BNP") and MACTEC, Inc. ("MACTEC") are parties to a certain Security Agreement dated as of November 21, 2001 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on August 5, 2002, at Reel 2554, Frame 0553, pursuant to which Mactec granted to BNP a security interest in the trademarks set out in Exhibit A hereto (the "Marks") and provided for the enforcement of such security interest; and
