RELEASE OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, Paribas ("Paribas") and MACTEC, Inc. ("MACTEC") are parties to a certain Security Agreement dated as of June 24, 1999 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on August 18, 1999, at Reel 1948, Frame 0246, pursuant to which MACTEC granted to Paribas a security interest in the trademarks set out in Exhibit A hereto (the "Marks") and provided for the enforcement of such security interest; and

WHEREAS, Paribas desires to: (i) release the security interest in the Marks; (ii) waive all of its right, title and interest in such Marks, and restore all such right, title and interest to the Marks to MACTEC; and (iii) dissolve any and all liens and encumbrances respecting the Marks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Paribas hereby releases its security interest in the Marks, terminates the Security Agreement, and releases and relinquishes any and all right, title and interest each of them has in and to the Marks, including but not limited to that recorded as reference on Exhibit A.
