RELEASE OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, BNP Paribas ("BNP") and MACTEC, Inc.; Pacific Environmental Services, Inc.; Validation and Process Associates, Inc.; Law Engineering & Environmental Services, Inc.; Law Companies Group, Inc.; NexDSS, Inc.; and Harding ESE ("Debtors") are parties to a certain Security Agreement dated as of February 15, 2002 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on August 19, 2002, at Reel 2565, Frame 0084, pursuant to which Debtors granted to BNP a security interest in the trademarks set out in Exhibit A hereto (the "Marks") and provided for the enforcement of such security interest; and

WHEREAS, BNP desires to: (i) release the security interest in the Marks; (ii) waive all of its right, title and interest in such Marks, and restore all such right, title and interest to the Marks to Debtors; and (iii) dissolve any and all liens and encumbrances respecting the Marks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BNP hereby releases its security interest in the Marks, terminates the Security Agreement, and releases and relinquishes any and all right, title and interest each of them has in and to the Marks, including but not limited to those recorded as reference on Exhibit A.
