This TRADEMARK RELEASE (this "*Release*") is made as of May 12, 2006 by KEYBANK NATIONAL ASSOCIATION, as Agent ("*Agent*").

### WITNESSETH:

WHEREAS, CSAC has transferred the SANI-SPEC Trademark to another entity and, in connection therewith, has requested Agent execute this Release.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


