

This **ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated June 30, 2006, by **SOFTCHOICE CORPORATION**, a Canadian corporation with offices at 173 Dufferin Street, Suite 200, Toronto, Ontario, M6K 3H7 ("*Softchoice*"), to and for the benefit of **WACHOVIA BANK, NATIONAL ASSOCIATION**, a national banking association with offices at 1 South Broad Street, 3<sup>rd</sup> Floor, Philadelphia, Pennsylvania 19107 ("*US Lender*"), and **WACHOVIA CAPITAL FINANCE CORPORATION (CANADA)**, an Ontario corporation with offices at 141 Adelaide Street West, Suite 1500, Toronto, Ontario M5H 3L5 ("*Canadian Lender*" and, collectively with US Lender, the "*Lenders*").

**WHEREAS**, Softchoice has adopted, used and is using the marks set forth in Schedule A attached hereto (the "*Marks*"), which are registered in the United States Patent and Trademark Office and/or for which applications are pending; and

**WHEREAS**, Softchoice is obligated to the US Lender pursuant to (i) a Modified and Restated Loan and Security Agreement, dated the date hereof (the "*US Loan Agreement*"), (ii) a General Security Agreement, dated the date hereof (the "*US Security Agreement*"), and (iii) an Amended and Restated Revolving Credit Master Promissory Note, dated the date hereof (the "*US Note*" and, collectively with the US Loan Agreement and the US Security Agreement, the "*US Loan Documents*"); and

**WHEREAS**, Softchoice is obligated to the Canadian Lender pursuant to (i) a Loan Agreement, dated the date hereof (the "*Canadian Loan Agreement*"), (ii) a General Security Agreement, dated the date hereof (the "*Canadian Security Agreement*"), and (iii) Revolving Credit Master Promissory Note, dated the date hereof (the "*Canadian Note*" and, collectively with the Canadian Loan Agreement and Canadian Security Agreement, the "*Canadian Loan Documents*"); and

**WHEREAS**, pursuant to the US Security Agreement and the Canadian Security Agreement, Softchoice is granting to each of the Lenders security interests in, among other personal property, the Marks, the goodwill of the Softchoice business associated with the Marks, and the registrations and pending applications therefor (collectively, the "*Intellectual Property*");

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Softchoice does hereby assign and grant to each of the US Lender and the Canadian Lender a security interest in and to the Intellectual Property, which assignment and security interest shall secure all of the Obligations, as defined in the US Loan Documents and the Canadian Loan Documents, in accordance with the respective terms and provisions thereof.


