TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 6, 2006, is made by Wells Fargo Bank, National Association, as Administrative Agent (the "Secured Party").
