**RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of this 24<sup>th</sup> day of March, 2006, by BANK OF AMERICA, N.A., in its capacity as agent (the "Administrative Agent"), for itself and each financial institution party from time to time to the Credit Agreement as defined below (the "Lenders").

WHEREAS, CAVALIER TELEPHONE, L.L.C., a limited liability company organized under the laws of the State of Virginia (the "Debtor"), the Administrative Agent, the Lenders and the other parties thereto entered into that certain Credit Agreement dated as of October 27, 1999 (as amended and restated, the "Credit Agreement").

WHEREAS, in connection with the Credit Agreement, the Debtor and the Administrative Agent entered into that certain License Agreement, dated as of October 27, 1999 (the "License Agreement").

WHEREAS, pursuant to the terms and conditions of the License Agreement, the Administrative Agent was granted a security interest in, among other things, all of Debtor's interest in the collateral more specifically described on Exhibit A attached hereto ("Collateral").

WHEREAS, in connection with the License Agreement a Notice of Security Interest in U.S. Trademarks (the "Notice") was filed with the United States Patent and Trademark Office on January 10, 2000, and recorded against the Collateral on Reel 02014, Frame 0504.

WHEREAS, the Administrative Agent now wishes to release such security interest and liens in the Collateral.

1. NOW THEREFORE, the Administrative Agent hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral.

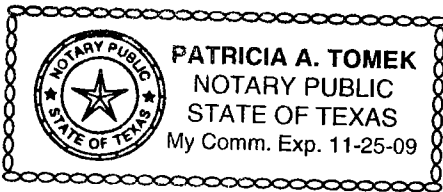
