## INTELLECTUAL PROPERTY SECURITY AGREEMENT

Nothing contained in this Intellectual Property Security Agreement shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Agent may have in any other collateral described in the Financing Agreement or otherwise. Capitalized terms used but not defined herein shall have the meanings given them in the Financing Agreement.
