NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its continuing security interest in and lien upon the Trademarks and interests of the Assignee in the Trademarks and reassigns any and all interest it may have in such Trademark to Assignee.

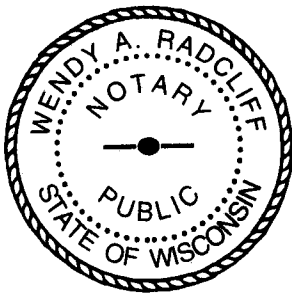

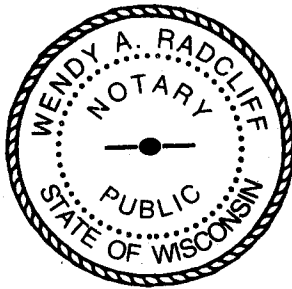
