INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement"), dated as of September 27, 2006, is made by and between **LESCO, INC.**, an Ohio corporation, **LESCO SERVICES, INC.**, an Ohio corporation, **LESCO TECHNOLOGIES, LLC**, a Nevada limited liability company and **AIM LAWN & GARDEN PRODUCTS, INC.**, an Ohio corporation (individually, a "Borrower" and collectively, the "Borrowers"), and **NATIONAL CITY BUSINESS CREDIT, INC.**, an Ohio corporation, in its capacity as agent (the "Agent") for the benefit of the Agent and the Lenders (as hereinafter defined).

Recitals

A. The Borrowers, the financial institutions which are now or which become a party thereto (individually, a "Lender;" and collectively, the "Lenders"), the Agent and National City Bank have entered into a Revolving Credit and Security Agreement of even date herewith (the "Credit Agreement") setting forth the terms on which the Lenders may now or hereafter make certain loans or other financial accommodations to or for the account of the Borrowers.

B. As a further condition of making any loan or financial accommodation under the Credit Agreement or otherwise, the Lenders require the execution and delivery of this Agreement by the Borrowers.

ACCORDINGLY, in consideration of the mutual covenants contained in the Credit Agreement and herein, the parties hereby agree as follows:

1. Definitions. All terms defined in the Recitals hereto or in the Credit Agreement that are not otherwise defined herein shall have the meanings given to them therein. In addition, the following terms have the meanings set forth below:

"Intellectual Property" means, collectively, the Patents, Trademarks and all products and proceeds thereof and the goodwill of the Borrowers' businesses connected therewith and/or symbolized thereby.

"Obligations" means each and every debt, liability and obligation of every type and description, whether arising under or in connection with the Credit Agreement and any Other Document or otherwise, which the Borrowers may now or at any time hereafter owe to the Lenders, whether such debt, liability or obligation now exists or is hereafter created or incurred and whether it is or may be direct or indirect, due or to become due, absolute or contingent, primary or secondary, liquidated or unliquidated, independent, joint, several or joint and several, and including specifically, but not limited to, the Obligations (as defined in the Credit Agreement).

“Patents” means any and all of the Borrowers’ rights, title and interest in and to patents or applications for patents, fees or royalties with respect to each, and including, without limitation, the right to sue for past, present and future infringement and damages therefor, and licenses there under, all as presently existing or hereafter arising or acquired, including, without limitation, the patents and patent applications listed on attached Exhibit A.

“Trademarks” means any and all of the Borrowers’ rights, title and interest in and to trademarks, service marks, collective membership marks, registrations and applications for registration for each, the respective goodwill associated with each, the right to sue for past, present and future infringement and damages therefore and licenses thereunder, all as presently existing or hereafter arising or acquired, including, without limitation, the marks listed on attached Exhibit B.

2. Security Interest. The Borrowers hereby pledge and assign to, and grant the Agent, on behalf of the Agent and the Lenders, a security interest, with power of sale, as set forth in Section 6 (the “Security Interest”), in the Intellectual Property to secure payment of the Obligations. As set forth in the Credit Agreement, the Security Interest is coupled with a security interest in substantially all of the personal property of the Borrowers.

3. Representations, Warranties and Agreements. The Borrowers hereby represent, warrant and agree as follows:

(a) *Existence; Authority*. The Borrowers have full power and authority to make and deliver this Agreement. The execution, delivery and performance of this Agreement by the Borrowers has been duly authorized by all necessary action of the Borrowers’ shareholders or members, as the case may be, and does not and will not violate the provisions of, or constitute a default under, any presently applicable law or any of Borrowers’ articles of incorporation or certificates of formation, bylaws, code of regulations, operating agreements or any other agreements presently binding on any one of Borrowers. This Agreement has been duly executed and delivered by the Borrowers and constitutes the Borrowers’ lawful, binding and legally enforceable obligation. The correct names of the Borrowers are: LESCO, Inc., LESCO Services, Inc., LESCO Technologies, LLC and AIM Lawn & Garden Products, Inc. The authorization, execution, delivery and performance of this Agreement do not require notification to, registration with or consent or approval by any federal, state or local regulatory body or administrative agency, except as contemplated by this Agreement.

(b) *Intellectual Property*. Exhibits A and B accurately list all Patents and Trademarks owned by the Borrowers as of the date hereof and accurately reflect the existence and status of the Intellectual Property as of the date hereof.

(c) *Title*. The Borrowers have sole title to the Intellectual Property listed on Exhibits A and B free and clear of all security interests, liens and encumbrances, except the Security

Interest. The Borrowers (i) will have, at the time the Borrowers acquire any rights in Intellectual Property hereafter arising, title to the Intellectual Property free and clear of all security interests, liens and encumbrances, except the Security Interest, and (ii) will keep all of the Intellectual Property free and clear of all security interests, liens and encumbrances except the Security Interest.

(d) *No Sale.* The Borrowers will not sell or otherwise dispose of the Intellectual Property, or any interest therein, without the Agent's prior written consent.

(e) *Defense.* The Borrowers will, at each of their own expense and using their best efforts, protect and defend the Intellectual Property against all claims or demands of all persons other than the Agent and the Lenders.

(f) *Intellectual Property is Valid and Enforceable.* None of the Intellectual Property has been adjudged invalid or unenforceable nor has any of the Intellectual Property been canceled, in whole or in part, and all of the Intellectual Property is presently subsisting. All of the Intellectual Property is properly filed, issued and/or valid.

(g) *Maintenance.* The Borrowers will, at their own expense, maintain the Patents and the Trademarks in such Borrowers' reasonable business judgment including, but not limited to, filing all applications and all affidavits and renewals possible to obtain or maintain issuance or registration. The Borrowers covenant that they will not abandon nor fail to pay any maintenance fee or annuity due and payable on any material Intellectual Property, nor fail to file any required affidavit in support thereof, without first providing the Agent sufficient written notice, as provided in the Credit Agreement, to allow the Agent the option to timely pay any such maintenance fees or annuity which may become due on any of said material Intellectual Property or to file any affidavit with respect thereto. In the event that Agent elects to pay any such maintenance fees or annuity which may become due on any of said material Intellectual Property or to file any affidavit with respect thereto, Borrowers will provide to the Agent a separate written power of attorney or other authorization to pay such maintenance fees or annuities, or to file such affidavit.

(h) *The Agent's Right to Take Action.* If any of the Borrowers fail to perform or observe any of its covenants or agreements set forth in this Section 3, and if such failure continues for a period of twenty (20) calendar days after the Agent gives the Borrowers written notice thereof (or, in the case of subsection (g), immediately upon the occurrence of such failure, without notice or lapse of time), or if any Borrower notifies the Agent that it intends to abandon any material Intellectual Property, Agent may (but need not) perform or observe such covenant or agreement on behalf and in the name, place and stead of the Borrowers (or, at the Agent's option, in the Agent's own name) and may (but need not) take any and all other actions which the Agent may reasonably deem necessary to cure or correct such failure.

(i) *Costs and Expenses.* Except to the extent that the effect of such payment would be to render any loan or forbearance of money usurious or otherwise illegal under any applicable law, the Borrowers shall pay the Agent on demand the amount of all monies expended {1010701:}

and all costs and expenses (including reasonable attorneys' fees) incurred by the Agent in connection with or as a result of the Agent's taking action under subsection (h) or exercising its rights under Section 6, together with interest thereon from the date expended or incurred by the Agent at the highest rate then applicable to any of the Obligations.

(j) *Power of Attorney.* To facilitate the Agent's taking action under subsection (g) and (h) and exercising its rights under Section 7, the Borrowers hereby irrevocably appoint (which appointment is coupled with an interest) the Agent, or its delegate, as the attorney-in-fact of the Borrowers with the right (but not the duty) from time to time to create, prepare, complete, execute, deliver, endorse or file, in the name and on behalf of the Borrowers, any and all instruments, documents, applications, financing statements and other agreements and writings required to be obtained, executed, delivered or endorsed by the Borrowers under Section 3, or necessary for the Agent, after an Event of Default and the exercise of Agent's rights and/or remedies, to enforce or use the Intellectual Property or to grant or issue any exclusive or non-exclusive license under the Intellectual Property to any third party, or to sell, assign, transfer, pledge, encumber or otherwise transfer title in or dispose of the Intellectual Property to any third party. The power of attorney granted herein shall terminate immediately upon the termination of the Credit Agreement as provided therein and the payment and performance of all Obligations.

4. The Borrowers' Use of the Intellectual Property. The Borrowers shall be permitted to control and manage the Intellectual Property, including the right to exclude others from making, using or selling items covered by the Intellectual Property and grant any licenses there under, in the same manner and with the same effect as if this Agreement had not been entered into, so long as no Event of Default occurs.

5. Events of Default. Each of the following occurrences shall constitute an event of default under this Agreement (herein called "Event of Default"): (a) any Default or Event of Default, each as defined in the Credit Agreement, shall occur; or (b) the Borrowers shall fail to observe or perform any covenant or agreement herein binding on it in accordance with the terms thereof; or (c) any of the representations or warranties contained in Section 3 shall prove to have been misleading in any material respect on the date when made or deemed to have been made.

6. Remedies. Upon the occurrence of an Event of Default and at any time thereafter, the Agent may, at its option, take any or all of the following actions:

(a) The Agent may exercise any or all remedies available under the Credit Agreement.

(b) The Agent may sell, assign, transfer, pledge, encumber or otherwise dispose of the Intellectual Property.

(c) The Agent may enforce the Intellectual Property and any licenses there under, and if the Agent shall commence any suit for such enforcement, the Borrowers shall, at the request of {1010701:}

the Agent, do any and all lawful acts and execute any and all proper documents reasonably required by the Agent in aid of such enforcement.

(d) The Agent may use the Intellectual Property on a worldwide basis, except as limited by the terms of such Intellectual Property, without liability for royalties or other related charges from the Agent to the Borrowers.

7. New Intellectual Property. The Borrowers represent and warrant that the Intellectual Property listed on Exhibits A and B, respectively, constitutes all of the Intellectual Property now owned by the Borrowers as of the date hereof. If, before all liabilities and obligations pursuant to the Credit Agreement shall have been satisfied in full, the Borrowers shall (a) become aware of any existing Intellectual Property of which the Borrowers have not previously informed the Agent, (b) obtain rights to any new Intellectual Property, or (c) become entitled to the benefit of any Intellectual Property which benefit is not in existence on the date hereof, the provisions of this Agreement above shall automatically apply thereto and the Borrowers shall give to the Agent prompt written notice thereof. The Borrowers hereby authorize the Agent to modify this Agreement by amending Exhibits A and B, as applicable, to include any such Intellectual Property.

8. The Agent's Right to Inspect. The Agent shall have the right, at any time and from time to time during normal business hours (upon not less than two (2) days prior notice to the Borrowers) and prior to payment in full of all liabilities and obligations pursuant to the Credit Agreement and the Other Documents, to inspect the Borrowers' premises and to examine the Borrowers' books, records and operations, including, without limitation, the Borrowers' quality control processes. The Borrowers agree to maintain the quality of any and all products in connection with which the Intellectual Property is used, consistent with the quality of said products as of the date hereof. Notwithstanding anything herein to the contrary, prior to the occurrence of an Event of Default that is continuing, the Agent shall conduct such inspections no more frequently than three (3) times per fiscal year. Upon the occurrence of an Event of Default, the Borrowers agree that Agent, or a conservator appointed by Agent, shall have the right to establish such additional product quality controls as Agent, or said conservator, in its sole judgment, may deem necessary to assure maintenance of the quality of products sold by the Borrowers under the Intellectual Property. The foregoing notwithstanding, Agent agrees to hold confidential and not disclose to any third party or use any information regarding any of the Intellectual Property unless such disclosure is required by applicable law or court order; provided, however, that Agent shall give Borrowers prior notice of the need for such disclosure. If an Event of Default shall have occurred, Agent may disclose information necessary to exercise its rights hereunder. This obligation of confidentiality shall survive the termination of this Agreement and the release of the lien herein unless such termination is due to an Event of Default.

9. Release of Security Interest. Upon payment in full and performance of the Obligations and upon the termination of the Credit Agreement as provided therein, Agent shall take such actions (including execution of all deeds, releases, termination statements and other discharges)

as may be necessary or proper to terminate the security interests created hereby and pursuant to the Credit Agreement.

10. Miscellaneous. This Agreement has been duly and validly authorized by all necessary action, corporate or otherwise. This Agreement can be waived, modified, amended, terminated or discharged, and the Security Interest can be released, only explicitly in a writing signed by the Agent.

A waiver signed by the Agent shall be effective only in the specific instance and for the specific purpose given. Mere delay or failure to act shall not preclude the exercise or enforcement of any of the Agent's rights or remedies. All rights and remedies of the Agent shall be cumulative and may be exercised singularly or concurrently, at the Agent's option, and the exercise or enforcement of any one such right or remedy shall neither be a condition to nor bar the exercise or enforcement of any other. The Agent shall not be obligated to preserve any rights the Borrowers may have against prior parties, to realize on the Patents or Trademarks at all or in any particular manner or order, or to apply any cash proceeds of Intellectual Property in any particular order of application. This Agreement shall be binding upon and inure to the benefit of the Borrowers and the Agent and their respective participants, successors and assigns and shall take effect when signed by the Borrowers and delivered to the Agent, and the Borrowers waive notice of the Agent's acceptance hereof. The Agent may execute this Agreement if appropriate for the purpose of filing, but the failure of the Agent to execute this Agreement shall not affect or impair the validity or effectiveness of this Agreement. A carbon, photographic or other reproduction of this Agreement or of any financing statement signed by the Borrowers shall have the same force and effect as the original for all purposes of a financing statement. This Agreement shall be governed by the internal law of the State of Ohio without regard to conflicts of law provisions. If any provision or application of this Agreement is held unlawful or unenforceable in any respect, such illegality or unenforceability shall not affect other provisions or applications which can be given effect and this Agreement shall be construed as if the unlawful or unenforceable provision or application had never been contained herein or prescribed hereby. Merely because the Intellectual Property may not be presently recorded in the name of the correct owner, such instance shall not affect or impair the enforceability or validity of this Agreement and shall not preclude the exercise or enforcement of any of the Agent's remedies and rights hereunder including, without limitation, with respect to the representations, warranties and agreements in Paragraph 3(c). All representations and warranties contained in this Agreement shall survive the execution, delivery and performance of this Agreement and the creation and payment of the Obligations.

THE PARTIES WAIVE ANY RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING BASED ON OR PERTAINING TO THIS AGREEMENT.
