
**AFFIDAVIT OF MERGER**

I, Beverly W. Jackson, being a duly appointed and acting Assistant Secretary of Wachovia Bank, National Association, hereby certify the following:

1. Effective March 1, 2006, Wachovia Bank, National Association, Charlotte, North Carolina (Charter No.1), merged with and into Western Financial Bank, National Association (Charter No. 24648), subsequent to the conversion on March 1, 2006, of Western Financial Bank, Irvine, California, to a national banking association named Western Financial Bank, National Association. 2. Wachovia Bank, National Association is a wholly-owned subsidiary of Wachovia Corporation.


