TERMINATION AND RELEASE OF SECURITY INTERESTS
IN INTELLECTUAL PROPERTY RIGHTS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY RIGHTS (this "Release") is made as of October 13, 2006 (the "Effective Date") among Solucient, LLC (the "Company"), each affiliate of the Company listed on Schedule I hereto (together with the Company, the "Grantors") and Wells Fargo Foothill, Inc., as administrative agent (in such capacity, the "Agent"), for the benefit of the Lenders Group and the Bank Product Providers (as defined in the Security Agreement referred to below).

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement, dated as of March 24, 2005 among the Grantors and the Agent (including the Trademark Security Agreement, the Copyright Security Agreement and the Patent Security Agreement contemplated thereby, each dated as of March 24, 2005, among the Grantors and the Agent, collectively the "Security Agreement"), the Grantors pledged, assigned and granted to the Agent a continuing security interest in all of their respective rights, titles and interests in and to the Collateral (as defined in the Security Agreement), including without limitation: (i) the trademark registrations set forth on Schedule II hereto, together with the goodwill associated therewith (collectively, the "Trademarks"), (ii) the copyright registrations set for on Schedule III hereto, together with the goodwill associated therewith (collectively, the "Copyrights"), and (iii) the patent registrations set for on Schedule IV hereto, together with the goodwill associated therewith (collectively, the "Patents");

WHEREAS, the Security Agreement relating to the Trademarks for Sachs Group, a New York general partnership, was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on May 11, 2005, at Reel 3081, Frame 0684; and for the Company, on April 7, 2005, at Reel 3086 and Frame 0535;

WHEREAS, the Security Agreement relating to the Copyrights for Sachs Group was recorded with the United States Copyright Office on May 10, 2005 at Volume 3524, page 821, and for the Company on April 7, 2005 at Volume 3522, page 307;

WHEREAS, the Security Agreement relating to the Patents for the Company was recorded with the Patent Division of the U.S. Patent & Trademark Office on April 7, 2005, at Reel 016026, Frame 0001;


AND WHEREAS, the Agent has terminated its security interest in the collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, the Copyrights and the Patents, without warranty or recourse.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, the Copyrights and the Patents, it hereby assigns and transfers such rights, title or interest to Grantors or the persons legally entitled thereto.
