TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT** dated as of September 15, 2006, is entered into by **Oneida Ltd.**, a Delaware corporation ("Oneida"), and each subsidiary of Oneida party to the Credit Agreement (the "Borrowers" and together with Oneida, the "Grantors") in favor of **Wachovia Bank, National Association**, as collateral agent for the benefit of the Secured Parties (in its capacity as collateral agent, the "Collateral Agent") (as amended, supplemented or otherwise modified from time to time, the "Agreement").

WHEREAS, the Grantors have entered into that certain Loan and Security Agreement, dated of as of the date hereof, among the financial institutions listed on the signature pages thereof (such financial institutions, together with their respective successors and assigns, are referred to hereinafter as the "Lenders"), the Grantors, Credit Suisse, as administrative agent for the Lenders, Wachovia Bank, National Association, as Collateral Agent and syndication agent for the Lenders and CIT Group / Commercial Services and Wells Fargo Foothill, LLC, as co-documentation agents for the Lenders (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"); and

WHEREAS, under the terms of the Credit Agreement, the Grantors have granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantors to the Collateral Agent for the ratable benefit of the Secured Parties, and have agreed as a condition thereof to execute this Agreement for recording with the United States Patent and Trademark Office and other applicable Governmental Authorities.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors and the Secured Parties hereby agree as follows:

SECTION 1. DEFINED TERMS. Capitalized terms not otherwise defined herein have the meanings set forth in the Credit Agreement.

SECTION 2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a first priority security interest in and continuing first lien on all of such Grantor's right, title, and interest in, to and under the following, whether now owned or existing or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral"):

(a) all trademarks, service marks, trade names, trademark and service mark applications, including, without limitation, those trademarks, service marks, and trademark and service mark applications listed on Schedule A;

(b) all extensions, renewals, and reissues of any of the foregoing,

(c) all licenses of any of the foregoing,

(d) all goodwill associated with or symbolized by of any of the foregoing,

(e) all rights to sue for past, present, and future infringement of any of the foregoing, and

(f) all other rights related to any of the foregoing.

SECTION 3. PRECEDENCE. The security interest granted hereby is granted in conjunction with the security interest granted to the Secured Parties under the Credit Agreement. The rights and remedies of the Secured Parties with respect to the security interest granted hereby are in addition to those set forth in the Credit Agreement. In the event of any conflict between the terms of this Agreement and the terms of the Credit Agreement, the terms of the Credit Agreement shall control.

SECTION 4. RECORDATION. Each Grantor authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.

SECTION 5. RELEASE OF SECURITY AGREEMENT. Upon (i) the sale, transfer or other disposition of any Trademark Collateral in accordance with the Credit Agreement or (ii) the Termination Date, the Collateral Agent shall execute and deliver to the Grantor all instruments and other documents as may be necessary or proper to release the lien on and security interest in the Trademark Collateral which has been granted hereunder.

SECTION 6. MODIFICATION OF AGREEMENT. This Agreement or any provision hereof may not be changed, waived, or terminated except in accordance with the amendment provisions of the Credit Agreement pursuant to which the Collateral Agent may modify this Agreement, after obtaining Grantor's approval, by amending Schedule A to include reference to any right, title or interest in any existing Trademarks or any Trademarks acquired or developed by Grantor after the execution hereof or to delete any reference to any right, title or interest in any Trademarks in which Grantor no longer has or claims any right, title or interest.

SECTION 7. GENERAL.

(a) Governing Law. THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.


(b) Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the Secured Parties and Grantors and their respective successors and assigns. Each Grantor shall not, without the prior written consent of the Secured Parties given in accordance with the Credit Agreement, assign any right, duty or obligation hereunder.

(c) Counterparts. This Agreement may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.






