## TRADEMARK SECURITY AGREEMENT TERMINATION AND RELEASE

This Trademark Security Agreement Termination and Release (this "Termination") is made as of October 6, 2006, by THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation.

### RECITALS

A. Pursuant to the terms of that certain Intellectual Property Security Agreement, dated as of July 22, 2005 (the "Security Agreement"), by and between THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation, in its capacity as Agent ("Agent") for the Lenders (as such term is defined in the Security Agreement), and OCEAN GARDEN PRODUCTS, INC., a California corporation ("Company"), Company granted to Agent a security interest in Collateral, as defined in the Security Agreement, including without limitation the trademark and service mark applications and registrations listed on Exhibit A attached hereto.

B. The Security Agreement was recorded at Reel 3137 and Frame 0734 on August 9, 2005.

C. The obligations underlying the security interest are no longer owed and Agent no longer has any interest in the Collateral.

D. Agent desires to terminate the Security Agreement and release its security interest in the Collateral.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby covenant and agree as follows:

1. The Security Agreement, and Agent's security interest in the Collateral (including without limitation the trademark and service mark registrations listed in Exhibit A), is hereby terminated and released.

2. Agent represents and warrants that it has full power and authority to execute this Termination and to release its security interest in the Collateral.

3. Agent represents and warrants that it has not assigned or otherwise encumbered the security interest in the Collateral and it reassigns to the Company any and all rights, titles and interests therein.

4. Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Termination.
