RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of November 3rd, 2006 ("Effective Date") by and between Fire-Trol Holdings, L.L.C., a Delaware Limited Liability Company with its principal office at 734 East Southern Pacific Drive, Phoenix, Arizona, 85034 ("Grantor"), and PNC Bank, National Association ("PNC"), as agent for various other financial institutions (together with PNC, collectively, the "Lenders") all of which are parties to the Agreements (defined below) (in such capacity, "Agent").

WHEREAS, Grantor and Agent entered into a Trademark Assignment of Security (the "Trademark Security Agreement") on August 7, 1998, as required by the Lenders pursuant to (i) a certain Revolving Credit, Term Loan and Security Agreement, dated August 7, 1998, among Agent, Lenders, and Grantor; and (ii) a certain Trademark Collateral Security Agreement, dated August 7, 1998, made by Grantor in favor of Agent (collectively, the "Agreements");

WHEREAS, Grantor executed and delivered the Agreements;

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Grantor granted to Agent a security interest in and to all of Grantor's right, title and interest in and to all of the trademark registrations set forth on Schedule A attached hereto (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and the registrations and applications therefor;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 21, 1998, at Reel 1772, Frame 0018; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Agent, and the Grantor and the Agent wish to terminate the Trademark Security Agreement and release the security interests that Grantor had previously granted to the Agent for the benefit of the Agent and Lenders.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Trademarks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor.

Agent shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
