RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of October 24, 2006, is made by The Royal Bank of Scotland plc, as administrative agent (the "Administrative Agent") under the Credit Agreements referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreements).

WHEREAS, NUSIL ACQUISITION CORP, a Delaware corporation, ("Borrower") and the Administrative Agent entered into (i) that certain CREDIT AND GUARANTY AGREEMENT (the "First Lien Credit Agreement"), dated as of June 13, 2005, entered into by and among Borrower, Administrative Agent, NUSIL TECHNOLOGY LLC, a Delaware limited liability company ("Opco"), NUSIL INVESTMENTS LLC, a Delaware limited liability company ("Holdings"), each entity listed as a "Guarantor" on the signature pages thereto, as Guarantors, the financial institutions party thereto from time to time, Lead Arranger, Sole Bookrunner, Syndication Agent and Documentation Agent and (ii) that certain SECOND LIEN CREDIT AND GUARANTY AGREEMENT (the "Second Lien Credit Agreement", and together with the First Lien Credit Agreement, the "Credit Agreements") entered into by and among Borrower, Administrative Agent, Opco, Holdings, each entity listed as a "Guarantor" on the signature pages thereto, as Guarantors, the financial institutions party thereto from time to time, Lead Arranger, Sole Bookrunner, Syndication Agent and Documentation Agent;

WHEREAS, in connection with the Credit Agreements, Opco granted security interests in certain intellectual property owned by Opco listed on Annex I attached hereto (collectively, the "IP Collateral");

WHEREAS, (i) that certain Trademark Security Agreement, dated June 13, 2005, between Opco and the Administrative Agent was recorded in the U.S. Patent and Trademark Office on June 16, 2005, and on the reel/frame 3106/0704 (the "First Lien Trademark Security Agreement") and (ii) that certain Second Lien Trademark Security Agreement, dated June 13, 2005, between Opco and the Administrative Agent was recorded in the U.S. Patent and Trademark Office on June 16, 2005, and on the reel/frame 3106/0847 (the "Second Lien Trademark Security Agreement"); and


WHEREAS, (i) that certain Patent Security Agreement, dated June 13, 2005, between Opco and the Administrative Agent was recorded in the U.S. Patent and Trademark Office on September 16, 2005, and on the reel/frame 016976/0571 (the "First Lien Patent Security Agreement") and (ii) that certain Second Lien Patent Security Agreement, dated June 13, 2005, between Opco and the Administrative Agent was recorded in the U.S. Patent and Trademark Office on June 16, 2005, and on reel/frame 016145/0674 (the "Second Lien Patent Security Agreement, and together with the First Lien Patent Security Agreement, the First Lien Trademark Security Agreement and the Second Lien Trademark Security Agreement, the "Security Agreements").

NOW THEREFORE, the Administrative Agent hereby RELEASES, without representation, recourse or warranty whatsoever, all of its security interest in the IP Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreements, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the IP Collateral to Opco.

The Administrative Agent agrees, at Opco's expense, to cooperate with Opco and its Subsidiaries and to provide Opco and its Subsidiaries with the information and additional authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the released collateral described herein.
