FULL RELEASE AND REASSIGNMENT OF  
TRADEMARKS AND TRADEMARK APPLICATIONS

Reference is hereby made to that certain security agreement, dated as of October 25, 2002, executed by BURKE INDUSTRIES (DELAWARE), INC., a Delaware corporation ("Burke Delaware"), in favor of Wells Fargo Business Credit, Inc. (now known as Wells Fargo Bank, N.A.) WHEREAS, Assignee wishes to terminate the Agreements and release, retransfer and reassign to Burke Delaware without representation or warranty, all of Assignee's right, title and interest in and to the Trademarks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee hereby terminates the Agreements and releases, retransfers and reassigns to Burke Delaware, without representation or warranty, all of Assignee's right, title and interest in and to the Trademarks and the goodwill associated therewith.
