ASSIGNMENT OF U.S. TRADEMARK & REGISTRATION

Weyerhaeuser agrees to provide such further documents and to obtain/execute/provide such further instruments as are necessary to properly transfer the above identified registration to Hemisphere. Hemisphere acknowledges that the rights granted herein are granted to Hemisphere on a quitclaim basis. Hemisphere further acknowledges that Weyerhaeuser shall have no obligation whatsoever to Hemisphere in connection with any claim or action arising out of, or in connection with the rights granted herein.

Weyerhaeuser represents and warrants that it knows of no contractual restrictions which limit the scope of the trademarks rights.
