ASSIGNMENT FOR SECURITY

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Assignment can be waived, modified, amended, terminated or discharged only explicitly in a writing signed by the Assignee.
