**TRADEMARK SECURITY AGREEMENT**

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 21, 2006, by BANK OF AMERICA, N.A. ("Deposit Bank"), in connection with that certain Trademark Security Agreement, dated as of December 16, 2005 (as amended and in effect prior to the date hereof, "Trademark Agreement"), between PLVTZ, LLC, a Delaware limited liability company ("Grantor") and Deposit Bank.

WHEREAS, Grantor and Deposit Bank entered into that certain Trademark Agreement, which was recorded on February 8, 2006 with the United States Patent and Trademark Office at Reel 3243, Frame 0462, for the purpose of securing payment and performance of the Cash Management Obligations (as defined in the Trademark Agreement);

WHEREAS, pursuant to the Trademark Agreement, Grantor granted to Deposit Bank, a security interest in, and granted, assigned and conveyed to Deposit Bank, by way of collateral security, such Grantor's entire right, title and interest in and to, the Trademark Collateral (as defined in the Trademark Agreement); and

WHEREAS, Deposit Bank has agreed to terminate and release the Trademark Agreement and assign and transfer to such Grantor Deposit Bank's right, title and interest in the Trademark Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Deposit Bank hereby terminates and releases the Trademark Agreement, discharges all of Deposit Bank's security interest in the Trademark Collateral and all other security interests granted under the Trademark Agreement and assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Deposit Bank's right, title and interest in and to the Trademark Collateral including, without limitation, the trademarks, service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Exhibit A attached hereto, effective as of the date set forth above.

The parties hereby acknowledge that this document shall be filed along with any other necessary documentation with the United States Patent and Trademark Office, or any applicable state trademark office, to evidence the termination and release granted herein. Deposit Bank hereby agrees to deliver any further releases or termination statements as may be reasonably necessary to effect the termination and release contemplated hereby, at Grantor's expense.
