**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE, dated as of September 26, 2006, from Bank of America, N.A. (the "Bank of America"), with a business address at 335 Madison Avenue, 5<sup>th</sup> floor, New York, NY 10017.

WITNESSETH:

WHEREAS, Straight Arrow Publishers Company, L.P., predecessor-in-interest of Rolling Stone LLC, granted a security interest (the "Security Interest") to Continental Bank, N.A. ("Continental Bank"), on June 20, 1994 in the trademarks listed on Schedule A attached hereto (the "Trademarks");

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on July 27, 1994 at Reel 1188 and Frame 0225;

WHEREAS, Continental Bank has been merged into Bank of America, and Bank of America has succeeded to all of Continental Bank's rights, titles and interests; and

WHEREAS, Bank of America now desires to terminate and release the entirety of its Security Interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Bank of America hereby acknowledges and agrees as follows:

1. Release of Security Interest. Bank of America, as successor-in-interest to Continental Bank, hereby terminates, releases and discharges its Security Interest in the Trademarks, and all right, title and interest of Bank of America, as successor-in-interest to Continental Bank, in such Trademarks shall hereby cease and be void.

2. Further Assurances. Bank of America, as successor-in-interest to Continental Bank, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
