AMENDED AND RESTATED TRADEMARK
AND TRADE NAME SECURITY AGREEMENT

THIS AMENDED AND RESTATED TRADEMARK AND TRADE NAME SECURITY AGREEMENT (“**Agreement**”) is between TROJAN BATTERY COMPANY, a California corporation with its chief executive office at 12380 Clark Street, Santa Fe Springs, California 90670 (the “**Debtor**”), and BANK OF AMERICA, N.A., a national banking association with an office at 333 S. Hope Street, Suite 1300, Los Angeles, California 90071 (the “**Secured Party**”).

WHEREAS, the Debtor has acquired, adopted, and used, and is using, the trademarks and/or trade names listed in Exhibit A attached hereto and made a part hereof, which, as indicated in Exhibit A, are registered in the United States Patent and Trademark Office.

WHEREAS, the Debtor and the Secured Party have concurrently herewith entered into both that certain Second Amended and Restated Credit Agreement (the “**Credit Agreement**”) and that certain Amended and Restated Security Agreement (the Credit Agreement and Security Agreement referred to collectively herein as the “**Loan Agreement**”) by which the Secured Party has acquired, among other things, security interests in said trademarks and trade names and the applications or registrations thereof. Initially capitalized terms used but not defined herein have the respective meanings set forth in the Credit Agreement.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor does hereby grant and convey a lien and security interest to the Secured Party in all rights, titles, and interests of the Debtor in and to said trademarks and trade names, together with the goodwill of the business symbolized by such trademarks and trade names, and in the registrations or applications for registration thereof (all such property being referred to collectively herein as the “**Trademark Collateral**”).

The Debtor further represents and warrants to the Secured Party as follows:

(a) the Debtor is the sole and exclusive owner of the Trademark Collateral and all rights comprised of the Trademark Collateral, subject to limitations imposed by law and Permitted Liens, and has the corporate authority to grant this lien and security interest;

(b) Except as set forth on Exhibit B attached hereto and made a part hereof, the Trademark Collateral is in all aspects free and clear of any encumbrances other than Permitted Liens;

(c) to the best knowledge of the Debtor, the Trademark Collateral does not infringe on or conflict with any other Person’s property in any material respect, and no Person’s property infringes on or conflicts with the Trademark Collateral in any material respect;

(d) Except as set forth on Exhibit C attached hereto and made a part hereof, the Debtor has not entered into any contract or made any commitment that will or could reasonably be expected to impair the Secured Party's rights hereunder; and

(e) Except for Permitted Liens or as set forth on Schedule 6.12 to the Credit Agreement, as of the Closing Date, the Trademark Collateral and all rights comprised of the Trademark Collateral are not licensed or subject to a similar arrangement.

THIS AMENDED AND RESTATED TRADEMARK AND TRADE NAME SECURITY AGREEMENT SHALL BE INTERPRETED AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO DETERMINED IN ACCORDANCE WITH APPLICABLE FEDERAL LAW AND THE INTERNAL LAWS OF THE STATE OF NEW YORK.
