ASSIGNMENT OF TRADEMARKS

WHEREAS, RD Publications, Inc., a corporation organized and existing under the laws of the state of Delaware (hereinafter referred to as "Assignor"), is the owner of the entire right, title and interest in and to the trademarks identified on Schedule A attached hereto together with the goodwill related thereto (hereinafter collectively referred to as the "Marks"); and

WHEREAS, AW Media, LLC, a limited liability company organized and existing under the laws of state of Delaware (hereinafter referred to as "Assignee"), is desirous of acquiring the entire right, title and interest in and to the Marks and the business and goodwill of the business in connection with which the aforesaid Marks have been used; and

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement dated December 4, 2006 (the "Asset Purchase Agreement"), pursuant to the terms of which Assignor agreed to assign all right, title and interest of Assignor in and to all Business Intellectual Property (as defined in the Asset Purchase Agreement), including all trademarks, service marks, trade dress, trade names, logos and names, whether registered or unregistered and registrations and applications for registration thereof, together with all of the goodwill associated therewith; and

WHEREAS, Assignor has agreed to execute such additional instruments as may be necessary or desirable to confirm such assignment to Assignee;

NOW THEREFORE, in consideration of the foregoing, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to the Marks, together with the business and goodwill of the business in connection with which the Marks have been used, and all claims, if any, which may have arisen thereunder prior to the date of this instrument. The Assignor hereby agrees to execute any and all documents or instruments that may be necessary or proper to confirm, perfect or protect Assignee's ownership of the Marks.

This Assignment shall not be construed as a waiver of, or to limit, terminate, modify or derogate from the representations, warranties, covenants and agreements set forth in the Asset Purchase Agreement.
