INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT (the "Agreement") dated as of August 11, 2006 by and among Textron Inc., a Delaware corporation ("Parent"), Textron Innovations Inc. ("TII"), Avdel Cherry Rhode Island Inc. ("Avdel"), Textron Rhode Island Inc. ("TRI"), Ring Screw Textron Inc. ("Ring Screw") (together, "Assignors"), and Camcar Intellectual Properties, LLC, a Delaware limited liability company ("Purchaser"). Except as expressly defined herein, capitalized terms used in this Agreement shall have the meaning ascribed to them in the Purchase Agreement dated as of May 31, 2006, (the "Purchase Agreement") by and between Parent and TFS Acquisition Corporation.

WHEREAS, Parent and TFS Acquisition Corporation entered into the Purchase Agreement providing for the sale of the FS Business (as defined in the Purchase Agreement) to Purchaser;

WHEREAS, Parent, on behalf of itself and its Non-FS Subsidiaries (as defined in the Purchase Agreement) other than TII, Avdel, TRI, and Ring Screw, and as successor-in-interest to Shamrock Fastener Technologies L.L.C., and TII, Avdel, TRI, and Ring Screw, each on behalf of itself, desire to assign to Purchaser, and Purchaser desires to obtain and assume from Parent and its Non-FS Subsidiaries, TII, Avdel, TRI, and Ring Screw, certain assets, Contracts, liabilities and other obligations relating to the FS Business; and

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

1. Contracts.

(a) Subject to Section 1(c), Assignors hereby assign, transfer, convey and deliver to Purchaser, its successors and assigns, all of Assignors' respective right, title and interest in and to the Contracts described in Exhibit A hereto.

(b) Purchaser hereby (i) accepts the foregoing assignment, transfer, conveyance and delivery, and (ii) assumes and agrees to discharge and perform all of the liabilities and obligations that relate thereto, whether such liabilities or obligations relate to or arise out of facts, circumstances, events, incidents, actions or operations occurring, existing or asserted before, on or after the date hereof.

(c) Notwithstanding anything in this Agreement to the contrary, this Agreement shall not constitute an agreement to transfer or assign, or an assignment of, any Contract described in Exhibit A hereto that is not assignable without the consent, approval or waiver of a third party, which consent, approval or waiver has not been obtained on or before the date hereof (the "Unassigned Contracts"). Any transfer or assignment to the Company of any such Unassigned Contract or any claim or right or any benefit arising thereunder or

resulting therefrom, which shall require the consent, approval or waiver of any third party, is subject to such consent, approval or waiver being obtained.

(d) With respect to any Unassigned Contract: (i) Assignors shall use commercially reasonable efforts in cooperation with Purchaser to (A) provide or cause to be provided to Purchaser the benefits of the Unassigned Contract, (B) cooperate in any arrangement that is reasonable and lawful as to Assignors, designed to provide such benefits to Purchaser, (C) enforce for the account of Purchaser any rights of Assignors arising from the Unassigned Contract, including the right to elect to terminate such Unassigned Contract in accordance with the terms thereof on the request of Purchaser and (D) obtain the approval, consent or waiver of the third party to the transfer or assignment to Purchaser of the Unassigned Contract; provided, that such cooperation shall not include any requirement on the part of any Assignor to expend money, commence or participate in litigation or offer or grant any material (in the context of such Contract) accommodation (financial or otherwise) to a third party; (ii) Purchaser shall (A) use commercially reasonable efforts in cooperation with Assignors to obtain the approval, consent or waiver of the third party to the transfer or assignment to Purchaser of the Unassigned Contract, and (B) perform, at no cost to Assignors, the obligations of Assignors arising from or with respect to the Unassigned Contract; and (iii) the consummation of the transactions contemplated hereby shall not be deemed to have resulted in the assignment of any Unassigned Contract. If and when any such third-party approval, consent or waiver shall be obtained or such Unassigned Contract shall otherwise become assignable, Assignors will promptly assign, transfer, convey and deliver to Purchaser all of their respective rights, title and interest in and to, and Purchaser shall assume any and all of Assignors' liabilities and obligations under, such Unassigned Contract, and Purchaser shall discharge and perform all of the liabilities and obligations relating thereto.

2. Patents and Patent Applications; Trademarks, Trademark Applications, Trademark Registrations, and Common Law Trademarks.

(a) To the extent permitted by law, Assignors, hereby assign, transfer, convey and deliver to Purchaser, its successors and permitted assigns, (i) all of their respective right, title and interest in and to all patents and patent applications (including without limitation all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and the inventions disclosed or claimed therein) set forth on Exhibit B hereto (along with the right to sue for past or ongoing infringement), and all trademarks, trademark applications, trademark registrations, and common law trademarks (including without limitation all extensions or renewals thereof) set forth in Exhibit C hereto (along with the goodwill of the business symbolized by such trademarks and the right to sue for past or ongoing infringement), and (ii) all liabilities and obligations of Assignors to the extent based upon, arising out of or relating to such assets.

(b) Purchaser hereby (i) accepts the foregoing assignment, transfer, conveyance and delivery, and (ii) assumes and agrees to discharge and perform all of the liabilities and obligations so assigned, transferred, conveyed or delivered and all liabilities and obligations that relate thereto, whether such liabilities or obligations relate to or arise out

of facts, circumstances, events, incidents, actions or operations occurring, existing or asserted before, on or after the date hereof.

3. Interpretation.

(a) Capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Purchase Agreement.

(b) Whenever the words “include,” “includes” or “including” are used in this Agreement they shall be deemed to be followed by the words “without limitation.”

(c) The plural of any defined term shall have a meaning correlative to such defined term, the singular of any defined term shall have a meaning correlative to such term defined in the plural and words denoting any gender shall include all genders. Where a word or phrase is defined herein, each of its other grammatical forms shall have a corresponding meaning.

(d) A reference to any party to this Agreement or any other agreement or document shall include such party’s permitted successors and permitted assigns.

(e) The parties have participated jointly in the negotiation and drafting of this Agreement. In the event an ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by the parties, and no presumption or burden of proof shall arise favoring or disfavoring any party by virtue of the authorship of any provisions of this Agreement.

4. Miscellaneous.

(a) This Agreement shall be governed by, and construed in accordance with, the Laws of the State of Delaware, without regard to any conflict of laws principles thereof.

(b) Each party unconditionally and irrevocably agrees to submit to the exclusive jurisdiction of the state courts of the State of Delaware for the purpose of any dispute, controversy or claim arising under or relating to this Agreement or the breach, termination or validity thereof. Each party unconditionally and irrevocably waives any objections which they may have now or in the future to such jurisdiction, including any objections by reason of lack of personal jurisdiction, improper venue or inconvenient forum.

(c) This Agreement shall inure to the benefit of and shall be binding upon the parties hereto and their respective assigns and successors.

(d) This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

(e) This Agreement may be amended only by a written agreement signed by Purchaser and Parent.

(f) Any notice, request, instruction or other document to be given hereunder by any party to another party shall be given in the manner and to the parties specified in the Purchase Agreement.

(g) In case any term, provision, covenant or restriction of this Agreement is held to be invalid, illegal or unenforceable in any jurisdiction, the validity, legality and enforceability of the remaining terms, provisions, covenants or restrictions, or of such term provision, covenant or restriction in any other jurisdiction, shall not in any way be affected or impaired thereby.


