**U.S. TRADEMARKS RELEASE OF SECURITY INTEREST**

THIS RELEASE dated as of January 12, 2007, by JPMorgan Chase Bank, N.A., as Collateral Agent for the Lenders. Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Credit Agreement.

Reference is made to (a) the Credit Agreement dated as of August 20, 2004, as amended by the First Amendment dated as of May 4, 2005, the Second Amendment and Waiver dated as of August 8, 2005 and the Third Amendment and Restatement dated as of November 4, 2005 (as amended, supplemented or otherwise modified, the "Credit Agreement"), among Blockbuster Inc. (the "Borrower"), the lenders party thereto and JPMorgan Chase Bank, N.A., as Administrative and Collateral Agent, (b) the Security Agreement dated as of August 8, 2005 (as amended, supplemented or otherwise modified, the "Security Agreement"), among the Borrower, the subsidiaries of the Borrower party thereto and the Collateral Agent and (c) the Patent and Trademark Security Agreement dated as of August 8, 2005 (as amended, supplemented or otherwise modified, the "Trademark Security Agreement"), among the Borrower, the subsidiaries of the Borrower party thereto and the Collateral Agent pursuant to which, among other things, the Borrower granted a security interest to the Collateral Agent, for the benefit of the Lenders, in, among other things, the Trademarks (as defined in the Security Agreement) set forth on Exhibit A hereto (the "Released Trademarks").

The Borrower has informed the Collateral Agent that, pursuant to that certain Stock Purchase Agreement dated as of November 9, 2006, among Blockbuster Inc., GBI, and GameStop, Inc., Game Brands Inc. ("GBI") has ceased to be a Subsidiary as a result of the sale of 100% of the Equity Interests in GBI by the Borrower to GameStop, Inc. and the Borrower has sold the Released Trademarks to GameStop, Inc. Accordingly, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby reassigns to the Borrower all of the Collateral Agent's right, title and interest in and to the Released Trademarks and to the extent that the Security Agreement created a security interest in such Released Trademarks, the Collateral Agent hereby releases such security interest.
