**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Termination") is executed and delivered as of the 23 day of January, 2007 by Citizens Bank of Pennsylvania, a Pennsylvania chartered bank (the "Secured Party"), to Environmental Reclamation Services, Inc. (f/k/a Fugate and Associates, Inc. d/b/a ERS Imaging Supplies, Inc.), a Pennsylvania corporation (the "Company").

**BACKGROUND**

- A. On April 29, 2003, the Company executed and delivered to the Secured Party a Security Agreement (the "Security Agreement").
- B. Pursuant to the Security Agreement, the Company granted to the Secured Party a security interest in the trademarks set forth on Exhibit A attached hereto and made a part hereof (the "Security Interest").
- C. The Security Interest was recorded in the United States Patent and Trademark Office ("USPTO") at Reel/Frame 2768/0284.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

- 1. The Secured Party terminates and releases all of its rights, title and interest in the trademarks set forth on Exhibit A.
- 2. The Company, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.
- 3. The Secured Party agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, to carry out the intentions of this Termination.
