**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK AND PATENT RIGHTS**

TERMINATION AND RELEASE dated as of January 25, 2007, from Bear Stearns Corporate Lending Inc., a Delaware corporation, as First and Second Lien Collateral Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to International Mill Service, Inc., a Pennsylvania corporation (the "Borrower"), with its principal place of business located at 1155 Business Center Drive Horsham, PA 19044-3454.

WITNESSETH:

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement dated as of October 26, 2004, the Second Lien Guarantee and Collateral Agreement dated as of October 26, 2004, the Amended and Restated First Lien Guarantee and Collateral Agreement dated as of December 21, 2004, and the Amended and Restated Second Lien Guarantee and Collateral Agreement dated as of December 21, 2004, made by the Grantors (as defined therein) in favor of the Agent (the "Guarantee and Collateral Agreements"), first priority and a second priority security interests (the "Security Interests") were granted by the Grantors to the Agent in certain collateral, including the Patent Collateral and Trademark Collateral (hereinafter defined);

WHEREAS, pursuant to certain Grants of Security Interest in Patent Rights and Grants of Security Interest in Trademark Rights, dated as of November 16, 2004, and December 21, 2004, among the Agent and Borrower (the "Security Agreements"), Borrower, reaffirmed its intent to grant the Security Interests to the Agent specifically in certain Patent Collateral and Trademark Collateral;

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office on November 22, 2004 in the Patent Division at Reel 015377 and Frame 0727, and at Reel 015377 and Frame 0736, and in the Trademark Division at Reel 2979 and Frame 0001, and at Reel 2979 and Frame 0019, and on February 2, 2005, in the Patent Division at Reel 015629 and Frame 0697, and at Reel 015629 and Frame 0706, and in the Trademark Division at Reel 3020 and Frame 0698, and at Reel 3020 and Frame 0707;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interests in the Patent Collateral and Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral and Trademark Collateral pursuant to the Guarantee and Collateral Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Patent Collateral", as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Patents (including, without limitation, those items listed on Schedule A hereto). The term "Trademark

Collateral”, as used herein, shall mean all of the Grantors’ right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The terms “Patents” and “Trademarks” shall have the meaning provided by reference in the Guarantee and Collateral Agreements.


2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interests in the Patent Collateral and Trademark Collateral, and any right, title or interest of the Agent in such Patent Collateral and Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interests contemplated hereby.


