RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made by Bank of America, N.A., successor to Fleet Capital Corporation, this ~~Nth~~<sup>12th</sup> day of December 2006.

WHEREAS Zartic, Inc., a Georgia Corporation ("Zartic") and BankBoston, N.A. were parties to a certain trademark security agreement executed on May 28, 1997 (the "Security Agreement");

WHEREAS pursuant to the Security Agreement and other loan documents, BankBoston, N.A. extended credit to Zartic and Zartic granted to BankBoston, N.A. a security interest in all right, title, and interest in and to certain trademarks, together with all the goodwill and other intangible assets associated with and represented by the trademarks, and applications for and registrations thereof (the "Trademark Collateral"), as listed in Exhibit A attached hereto;

WHEREAS BankBoston, N.A. merged with Fleet National Bank, N.A., creating Fleet National Bank, N.A.;

WHEREAS Fleet National Bank, N.A. assigned all of its interest in the Security Agreement to Fleet Capital Corporation;

WHEREAS Bank of America, N.A. acquired Fleet Capital Corporation by merger with Fleet Bank, N.A.;

WHEREAS through the aforementioned assignments and mergers, Bank of America, N.A. is now the ultimate and/or beneficial holder of the security interest in the Trademark Collateral;

WHEREAS Zartic, Inc. has satisfied in full its obligations under the Security Agreement and requests that Bank of America, N.A. release its security interest in the Trademark Collateral;

NOW, THEREFORE, in consideration of the above and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, Bank of America, N.A. releases its security interest in all of the Trademark Collateral; authorizes Zartic, Inc. to file in the appropriate filing offices, Uniform Commercial Code ("UCC") termination statements with respect to all relevant UCC filings made by Bank of America, N.A. (and/or its predecessors) with respect to the Trademark Collateral; and agrees to deliver to Zartic from time to time, such other documents and instruments as Zartic shall reasonably request to further evidence the release of the security interest in the Trademark Collateral.
