**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of January 30, 2007, is made by Bank of America, N.A. (formerly known as Bank of America NT & SA) ("Bank of America"), as Administrative Agent, in favor of Hard Rock Hotel, Inc. ("Hard Rock") as follows:

Bank of America agrees to provide Hard Rock with any information and additional authorization necessary to effect the release of Bank of America's security interest in the Released Trademark Collateral.

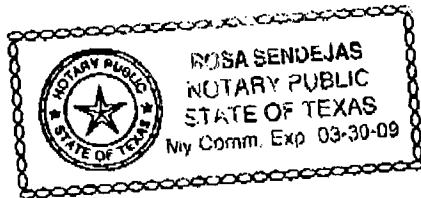
