WHEREAS, the Assignor is the sole and exclusive owner of all right, title and interest in and to the trademark listed on the attached Schedule (the "Trademark");

WHEREAS, Assignor and Assignee executed a Master Assignment of Trademarks, effective June 30, 2004, and attached hereto as Exhibit A;

WHEREAS, the Assignor intended to assign the Trademark to the Assignee, however, the Trademark was inadvertently and accidentally omitted from the Schedule to the Master Assignment of Trademarks; and

WHEREAS, the parties desire to document the assignment of the Trademark, effective June 30, 2004 and the Assignor confirms its desire to assign and the Assignee confirms its desire to obtain all right, title and interest in and to the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, Assignor and Assignee hereby agree as follows:

1. Assignor hereby sells, assigns, transfers and delivers to Assignee all of Assignor's right, title and interest that Assignor has or may have, either now or in the future, in and to the Trademark, together with the goodwill of the business which is symbolized by the Trademark and the right to sue and recover any damages and profits and all other remedies for past, present and future infringements or violations thereof, if there may be any;

2. Assignee hereby accepts the foregoing assignment and expressly assumes any and all liability, debts and obligations associated with the Trademark;

3. Assignee shall be responsible for and Assignor shall cooperate in the execution and delivery of any and all other instruments and papers and taking of any and all additional actions necessary to effectuate the purposes and intent of the transaction provided for herein and

otherwise to consolidate, vest and record in Assignee, full and complete ownership of the Trademark;

4. This Assignment shall inure to the benefit of the Assignee and its successor and assigns and shall be binding upon Assignor and its successors and assigns;

5. This Assignment and all questions relating to its validity, interpretation, performance and enforcement shall be governed by and construed in accordance with the laws of the State of Delaware without regard to its conflict of laws principles;

6. This Assignment contains the entire agreement and understanding of the parties hereto relating to the subject matter hereof, and merges and supersedes all prior and contemporaneous discussions, agreements and understanding of every nature between the parties hereto relating to the subject matter hereof. This Assignment may not be changed or modified, except by an agreement in writing signed by each of the parties hereto; and

7. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

**MASTER ASSIGNMENT OF TRADEMARKS**

THIS MASTER ASSIGNMENT OF TRADEMARKS is entered into as of July 1, 2004 (this "Assignment") by and between Bayer Chemicals Corporation, a Delaware corporation ("Seller"), and LANXESS Corporation, a Delaware corporation ("Buyer").

**RECITALS:**

A. Seller, Buyer, Bayer Corporation, an Indiana corporation, Bayer MaterialScience LLC (f/k/a Bayer Polymers LLC), a Delaware limited liability company, and Bayer Corporate and Business Services LLC, a Delaware limited liability company, have entered into that certain Sale and Purchase Agreement dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Purchase Agreement"), providing, subject to the terms and conditions set forth therein, for the sale, transfer, assignment, conveyance and delivery by Seller to Buyer of all of Seller's right, title and interest in and to the BCH Purchased Assets (as defined in the Purchase Agreement), including the BCH Intellectual Property (as defined in the Purchase Agreement) constituting a part thereof.

B. Seller has adopted certain trademarks, internet domain names and service marks described on Schedule A hereto (collectively, the "Trademarks"), each used in, attributable or related to, or associated with, the BCH Business (as defined in the Purchase Agreement).

C. Seller desires to sell, transfer, assign, convey and deliver to Buyer, and Buyer desires to acquire from Seller, the Trademarks, together with the goodwill symbolized by such Trademarks.

NOW, THEREFORE, in consideration of the mutual agreements contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties hereto hereby agree as follows:

1. Trademark Assignment. Seller hereby sells, transfers, assigns, conveys and delivers to Buyer the following:

(a) all of Seller's right, title and interest in and to the Trademarks, any and all registrations and applications therefor, and any and all renewals and extensions thereof, together with the goodwill of the BCH Business carried on in connection with such Trademarks; and

(b) all claims, demands and rights of action, both statutory and based upon common law, that Seller has or might have by reason of any infringement of any Trademark prior to, on or after the date of this Assignment, together with the right to prosecute such claims, demands and rights of action in Buyer's own name.

2. Further Assurance. Each of Seller and Buyer agrees that it shall do, execute, acknowledge and deliver, at the other party's expense, all acts, agreements, instruments,

notices and assurances as may be reasonably requested by the other party to further effect and evidence the transactions contemplated hereby, including without limitation, disclosing all facts known to it respecting the Trademarks and testifying in any legal proceeding involving enforcement of any of the Trademarks.

3. Trademark Issuance. Seller hereby authorizes the United States Patent and Trademark Office, and any official or agency of any country foreign to the United States whose duty it is to issue trademarks and service marks, to record Buyer as assignee and owner of all Trademarks (to the extent recordable), in accordance with the terms of this Assignment.

4. Amendment. This Assignment may be amended only with the express written consent of both parties.

5. Warranty. Seller hereby represents and warrants that it has the full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

6. No Third-Party Beneficiaries. This Assignment is not intended and shall not be construed to be for the benefit of any Person (other than the parties hereto and their respective successors and permitted assigns).

7. GOVERNING LAW. THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE, AND ALL RIGHTS AND REMEDIES SHALL BE DETERMINED UNDER SUCH LAWS, WITHOUT GIVING EFFECT TO THE PRINCIPLES OF CONFLICT OF LAWS.

8. Counterparts. This Assignment may be executed in counterparts, each of which shall be an original, and all of which together shall constitute one and the same document.

9. Successors and Assigns. This Assignment and the rights and obligations hereunder may not be assigned by either party without the express written consent of the other party (which consent may be refused by the other party in its sole discretion); provided, however, that this Assignment shall be binding upon, and inure to the benefit of, the successors of the parties (whether by purchase, merger, consolidation or otherwise) and any permitted assigns; provided further, that nothing herein shall be deemed to prohibit any future sale, transfer, assignment, conveyance or delivery by Buyer of the Trademarks.

10. Definitions; Purchase Agreement. Unless otherwise defined herein, each capitalized term used herein shall have the meaning assigned thereto in the Purchase Agreement. Notwithstanding anything in this Assignment to the contrary, the sale, transfer, assignment, conveyance and delivery effectuated hereby are subject in all respects to the terms and conditions of the Purchase Agreement (including Section 4.02 thereof).
