TRADEMARKS



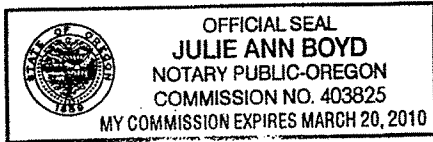
