
WHEREAS, the Grantors have entered into (i) the Credit and Guaranty Agreement dated as of January 26, 2007 (as modified from time to time, the "Credit Agreement") among Company, the Grantors, the other Grantors party thereto, the Lenders party thereto and Silver Point Finance, LLC, as Administrative Agent and Collateral Agent (in such capacity, the "Collateral Agent"), and (ii) the Pledge And Security Agreement dated as of January 26, 2007 (as modified from time to time, the "Pledge And Security Agreement"), in which the Grantors have granted certain interests in favor of the Collateral Agent for the benefit of the Secured Parties (as defined therein); and

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors have agreed with the Collateral Agent and the Lenders to execute this Trademarks Security Agreement (this "Agreement");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors hereby grant to the Collateral Agent for the benefit of the Secured Parties, to the extent provided in the Pledge and Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in all of their right, title and interest in, to, and under all the trademarks, whether now owned or at any time hereafter acquired, of the Grantors that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office, including without limitation the trademarks listed on the attached Schedule of Registered Trademarks, and all registrations and pending applications associated therewith (excluding any application for registration of a trademark filed on an intent-to-use basis solely to the extent that the grant of a security interest in any such trademark application would materially adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application), as collateral security for the prompt and complete payment and performance when due of all the Secured Obligations (as defined in the Pledge and Security Agreement). Notwithstanding the foregoing, in the event of any conflict between this Agreement and the Pledge and Security Agreement, the Pledge and Security Agreement shall control.
