NOW, THEREFORE, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, the sum of ten dollars (\$10.00) paid by Assignee to Assignor, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor by these presents, does hereby sell, assign, and transfer to Assignee its full right, title and interest, including common law rights, in the United States of America and in all countries and jurisdictions of the world, in, to and under said Trademarks, together with the goodwill of the business symbolized by the Trademarks, all renewal rights in said Trademarks, and Assignor's ongoing and existing business to which the Trademarks pertain, to be held and enjoyed by Assignee as fully and entirely as they would have been held and enjoyed by Assignor if this sale, assignment and transfer had not been made, including all claims, demands, and rights of recovery that Assignor has or may have in profits and damages for past and future infringements, if any, and all rights to compromise, sue for, and collect such profits and damages and the right to seek and obtain injunctive relief, as well as the right to invoke and claim the right of priority provided by the Paris Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, or under any other convention, protocol or law of any country which may be applicable to such Trademarks, said sale, assignment and transfer effective as of the date this document is executed by a duly authorized officer of Assignor (the "Effective Date").

SAID ASSIGNOR hereby consents that a copy of this assignment shall be deemed a full and formal equivalent of any assignment, consent to file, or like document, which may be required in any country or region for recordation purposes for any of the foregoing rights conveyed herein.

SAID ASSIGNOR hereby covenants that: (1) subject to the License Agreements, Assignor has the full right to convey the entire right, title, and interest herein assigned; (2) except for the License Agreements, Assignor has not executed and will not execute any assignment, sale, agreement or encumbrance in conflict herewith; and (3) subject to

the License Agreements, Assignor will, upon Assignee's request, promptly execute and deliver to Assignee or its legal representative any and all papers or instruments required to maintain, enforce or vest title in the Trademarks in Assignee or which may be necessary or desirable to carry out the purposes hereof.

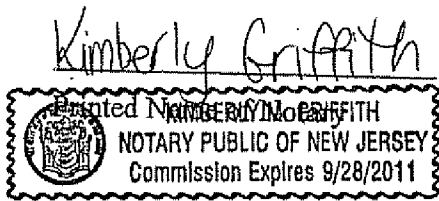
