**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of February 8, 2002, from WACHOVIA BANK, N.A. (the "Lender") to Encore Medical L.P., as successor in interest to the Chattanooga Group, Inc. (the "Borrower") pursuant to the Loan and Security Agreement, dated as of July 30, 1999 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), among Borrower and Lender.

WITNESSETH

WHEREAS, pursuant to the Loan Agreement, a security interest (the "Security Interest") was granted by the Borrower to the Lender in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 6, 1999, at Reel 1910 and Frame 698, and

WHEREAS, Lender, pursuant to the Letter Agreement, dated February 8, 2002, from Lender to Borrower, agreed to terminate and release the entirety of its Security Interest in the Trademark Collateral, as defined below, upon payment of all amounts owing to Lender by Borrower under the Loan Agreement, and execute all further documentation at the request of the Borrower;

WHEREAS, Borrower has repaid all amounts owing to Lender under the Loan Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby states as follows:


1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Borrowers' right, title and interest of every kind of nature as of the date hereof in the Trademarks listed on Schedule A hereto.
2. Release of Security Interest. The Lender hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
