TRADEMARK ASSIGNMENT

THIS ASSIGNMENT dated this 2nd day of March, 2001, from Georgia-Pacific Corporation ("Assignor"), a corporation with its principal address at 133 Peachtree Street, NE, Atlanta, GA 30303, to Georgia-Pacific Tissue LLC ("Assignee"), a Delaware Limited Liability Company with its principal address at 55 Park Place, Atlanta, GA 30303;

WITNESSETH

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademarks and trademark applications set forth in the Schedule A attached hereto (the "Trademarks");

WHEREAS, Assignee desires to obtain Assignor's entire right, title and interest in and to the Trademarks in all territories worldwide;

NOW, THEREFORE, for the sum of One dollar (\$1.00) US, and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, Assignor has agreed to sell and hereby sells, assigns, transfers, conveys and sets over unto Assignee and its successors and assigns, the entire right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by these marks, to be held and enjoyed by Assignee, and its successors and assigns, for their own use and enjoyment, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made, including, without limitation, the right to apply for, maintain and renew the registration of all the



Trademarks, the right to recover for past infringement and to make application or institute suit therefor.

Assignor hereby authorizes Assignee to apply for and obtain the recordation of this Assignment.

Assignor agrees that it shall, without further consideration, promptly and duly cause to be performed such lawful acts and execution of any other documents as Assignee may reasonably request in order for Assignee to obtain the full benefit of this Assignment and to permit Assignee to be duly recorded in each office, bureau and tribunal in the appropriate jurisdiction as the registered owner or proprietor of each of the rights hereby assigned. Such instruments and documents shall include, without limitation, affidavits, including affidavits of use, and other documents for filing in such jurisdictions as Assignee may from time to time reasonably request.

Assignor hereby represents and warrants that he has the full right to convey the entire interest herein assigned, that there are no rights and interests outstanding inconsistent with the rights and interests granted herein, and that Assignor shall not execute any instrument or grant or transfer any rights or interest inconsistent herewith.

AND it is further covenanted and agreed that Assignor shall, at any time upon request, comminute to said Assignee, its successors, assigns or other legal representatives, any facts relating to the Trademarks and the history thereof known to said Assignor and testify as to the same in any legal proceeding when requested to do so, sign all lawful papers, execute all other necessary assignment papers to cause the Trademarks to be issued to Assignee, make all rightful oaths and generally do everything necessary or



desirable to aid said Assignee, its successors and assigns to obtain perfect title in and enforce proper protection for the Trademarks in the United States and in any and all foreign countries.
