RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL

This RELEASE, dated as of April 2, 2007, is made by BANK OF AMERICA, N.A., as Administrative Agent (the "Administrative Agent"), pursuant to the termination of the Security Agreement, dated as of May 27, 2005 (the "Security Agreement") by and among Advanced Medical Optics, Inc., a Delaware corporation (the "Borrower"), Visx, Incorporated, a Delaware corporation, and the Additional Grantors (collectively, the "Grantors") and Bank of America, N.A., as administrative agent for the benefit of the Secured Parties.

WHEREAS, pursuant to the Security Agreement, recorded with the U.S. Patent and Trademark Office on August 4, 2005 at Reel/Frame Nos. 16345/0640, 16345/0707, 16345/0774, and 16352/0166, the Grantors granted the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Patents and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Security Agreement, recorded with the U.S. Patent and Trademark Office on July 21, 2005 at Reel/Frame No. 3125/0179 and the subsequent corrective assignment recorded on August 3, 2005 at Reel/Frame No. 3133/0663, the Grantors granted the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Trademarks, including all goodwill associated with such trademarks, and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Security Agreement, recorded with the U.S. Copyright Office on August 4, 2005 at Volume 3528/Document No. 382, the Grantors granted the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Copyrights, and proceeds of any and all of the foregoing;

WHEREAS, the Administrative Agent acknowledges full payment, complete performance and satisfaction of all obligations made under the Security Agreement;


WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in the Intellectual Property in connection with the termination of the Security Agreement.;

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby RELEASES, without recourse, all of its security interest in the Intellectual Property listed on Schedule I attached hereto and incorporated herein by reference (the "Released Collateral") to Grantor.
