## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release"), is granted and conveyed as of this 16 day of April, 2007, by CapitalSource Finance LLC, a Delaware limited liability company, as administrative agent and collateral agent ("Secured Party"), in favor of OMD Corporation, a Missouri corporation ("Grantor").

### WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Credit Agreement dated as of July 27, 2006, among Grantor, the other Credit Parties name therein, Secured Party and the Lenders (as the same has been amended, restated, supplemented, extended, renewed, replaced or otherwise modified from time to time, the "Loan Agreement"), the Lenders agreed to provide Loans to Grantor upon the terms and subject to the conditions set forth therein;

WHEREAS, Grantor granted to Secured Party, for itself and the benefit of the Lenders, certain liens on the Collateral to secure its Obligations under the Loan Agreement pursuant to the terms of the Security Agreement (as defined in the Loan Agreement and as amended pursuant to that certain Joinder Agreement dated as of December 12, 2006, by and among Grantor, Secured Party and the other Credit Parties named therein);

WHEREAS, pursuant to the terms of the Security Agreement, Grantor granted a security interest in and to certain tangible and intangible personal property, including, but not limited to, all of Grantor's trademarks, patents, copyrights and domain names as set forth on Schedule A attached hereto, together with any applications for registration and registrations therefor, and all goodwill associated therewith (collectively, the "Intellectual Property");

WHEREAS, pursuant to the terms of the Security Agreement, an Acknowledgement of Intellectual Property Collateral Lien dated as of December 12, 2006 was filed on behalf of Secured Party in the United States Copyright Office on January 4, 2007 to evidence the security interest granted to Secured Party;

WHEREAS, pursuant to the terms of the Security Agreement an Acknowledgement of Intellectual Property Collateral Lien dated as of December 12, 2006 was filed on behalf of Secured Party on December 29, 2006 in the United States Patent and Trademark Office, at Reel/Frame 3452/0979, to evidence the security interest granted to Secured Party; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations under the Loan Agreement, the Security Agreement and all other documents executed in connection with the foregoing agreements, and the parties seek to make a record of Secured Party's release and reassignments to Grantor of any and all of its security interests in the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby releases, discharges, and relinquishes its security interests in the Intellectual Property and all Copyright Licenses, Patent

Licenses and Trademark Licenses (as defined in the Security Agreement), all renewals or extensions of the foregoing, all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement or dilution of any Intellectual Property or Intellectual Property licensed under any Copyright License, Patent License or Trademark License. Secured Party specifically acknowledges that its security interests in the Intellectual Property are no longer in force and the Security Agreement is no longer effective.
