Ladies and Gentlemen:

Reference is made to (i) the Indenture, dated as of August 18, 2003 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Indenture"), made by and among Advanstar Communications Inc., a New York corporation (the "Company"), the Guarantors party thereto and Wells Fargo Bank, N.A. (as successor by merger to Wells Fargo Bank Minnesota, N.A.), as trustee (the "Trustee") for the benefit of the noteholders identified therein and (ii) the Issuer Pledge and Security Agreement (the "Security Agreement") dated as of August 18, 2003, as amended and restated or otherwise modified from time to time, between the Company in favor of Wells Fargo Bank, N.A. (as successor by merger to Wells Fargo Bank Minnesota, N.A.) in its capacity as trustee and collateral agent (the "Collateral Agent"). Unless otherwise defined in this letter, terms defined in the Indenture are used in this letter with the meanings set forth in the Indenture.

The undersigned represents that it is an authorized officer of the Company and hereby informs the Administrative Agent that the Company has entered into an Asset and Share Purchase Agreement (the "Purchase Agreement"), dated as of April 2, 2005, among the Company, Advanstar, Inc., a Delaware corporation, Advanstar Expositions Canada Limited, a Federal Canadian Corporation, and Advanstar.com, Inc., a Delaware corporation (collectively, the "Sellers"), and Questex Media Group, Inc. (the "Buyer"), an executed copy of which is attached hereto as Exhibit A, pursuant to which the Sellers are selling and the Buyer is buying (a) certain assets used in connection with the business of (i) publishing, marketing and selling the Publications (as defined in the Purchase Agreement), (ii) organizing, producing, marketing and selling the Shows (as defined in the Purchase Agreement) and (iii) owning and operating the Websites (as defined in the Purchase Agreement) (collectively, the "Business") and (b) 50,000 shares of Advanstar Asia Limited, a Hong Kong company, and 18,646,865 *quotas* of Advanstar Editora e Comunicacoes Ltda., a Brazilian limited liability company (the "Advanstar Brazil Interests"), and 50% of the outstanding partnership interests in Home Entertainment Events, a

Delaware general partnership, in each case owned by the Sellers (together with the Business, but solely to the extent that the foregoing property is being sold under the Purchase Agreement, the "Properties"). The undersigned hereby certifies that the Asset Sale is permitted by, and is being consummated in accordance with, the terms of the Indenture (including Section 4.10 of the Indenture) and that the Lien of the Security Documents and Indenture will be automatically released pursuant to Section 11.04(a) of the Indenture.

The portion of the Properties owned by the Company which have been pledged to the to the Collateral Agent in accordance with the Security Documents (collectively, the "ACI Properties") constitute Collateral under the Security Documents and the Indenture. The Company hereby requests in this release letter (the "Release Letter") that the Trustee instruct the Collateral Agent to execute this Instrument to confirm the release, as of May 23, 2005, of the Lien on, and security interest in, the ACI Properties other than the Advanstar Brazil Interests (the "Released Properties") (but not the proceeds thereof) created under the Security Documents and the Indenture. The Company acknowledges and agrees that such release is without any representation and warranty by the Trustee and Collateral Agent.

Each of the undersigned Officers hereby certifies that all conditions and covenants under the Indenture to the Trustee and Collateral Agent's execution of this instrument and confirmation of the release of the Lien of the Indenture and the Security Documents on the Released Properties have been satisfied. The undersigned Officers further certify that the release of the Lien of the Indenture on the Released Properties will not impair the security under the Indenture or Security Documents in contravention of the provisions thereof. The undersigned have read such conditions and covenants, and the statements of the undersigned contained herein are based upon their review of such conditions and covenants in the Indenture and the Security Documents and such other corporate records, certificates of public officials and other instruments as the undersigned Officers have deemed necessary for the purposes of rendering an opinion as to whether such conditions and covenants have been complied with. Each of the undersigned has made such examination or investigation as is necessary in the undersigned's opinion to enable the undersigned to express an informed opinion as to whether such conditions and covenants have been complied with.

This letter shall be construed in accordance with the terms of the Indenture.


