GRANT OF
SECURITY INTEREST IN TRADEMARK RIGHTS

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement"), effective as of June 29, 2006 is made by National Mentor Healthcare, LLC (f/k/a National Mentor Healthcare, Inc., a Delaware company, located at 313 Congress Street, 5th Floor, Boston, Suffolk, Massachusetts 02210 (the "Obligor"), in favor of JPMorgan Chase Bank, N.A., a national banking association, located at 227 Park Ave, 16th Floor, New York, NY 10172, as Administrative Agent (the "Agent") for the several banks and other financial institutions (the "Lenders"), parties to the Credit Agreement, dated as of June 29, 2006 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among National Mentor Holdings, Inc., a Delaware corporation, located at 313 Congress Street, 5th Floor, Boston, Suffolk, Massachusetts 02210 (the "Borrower"), the Lenders and the Agent.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection with the Credit Agreement, the Obligor and certain other subsidiaries of the Borrower has executed and delivered a Guarantee and Security Agreement, dated as of June 29, 2006, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Guarantee and Security Agreement");

WHEREAS, pursuant to the Guarantee and Security Agreement, the Obligor pledged and granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in all Intellectual Property, including the Trademarks; and

WHEREAS, the Obligor has duly authorized the execution, delivery and performance of this Agreement;


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans and other financial accommodations to the Borrower pursuant to the Credit Agreement, the Obligor agrees, for the benefit of the Agent and the Lenders, as follows:

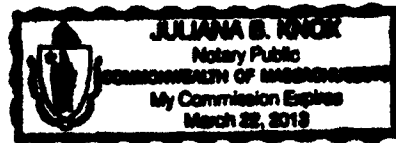
