TRADEMARK SECURITY AGREEMENT

WHEREAS, New Age Media of Maine, LLC, a Delaware limited liability company, as DEBTOR (hereinafter referred to as "Assignor"), with an address of c/o New Age Media Management, LLC, 1181 Highway 315, Wilkes-Barre, PA 18702 has purchased the right to use and is using the WPXT trademark, registered with the United States Patent and Trademark Office as Reg. No. 2,698,256 (the "Trademark");

WHEREAS, Assignor is a party to (a) that certain Credit Agreement, dated as of April 2, 2007, with Manufacturers and Traders Trust Company, as LENDER (hereinafter referred to as "Assignee") and the Secured Parties referred to therein (the "Credit Agreement"), (b) that certain Security Agreement dated as of April 2, 2007, in favor of Assignee, and (c) certain other Credit Documents referred to in the Credit Agreement (the agreements referred to in clauses (a), (b) and (c) collectively, the "Agreements"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby grant to Assignee a security interest in, and mortgage on, all right, title and interest of Assignor in and to the Trademark, and any applications and registrations therefor, as well as a security interest in, and mortgage on, the goodwill of the business connected with the use of and symbolized by the Trademark, and all proceeds thereof, including, without limitation, any and all causes of action for infringement thereof and any and all royalties for any licenses thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Secured Obligations, as defined in the Agreements. Assignor does hereby further acknowledge and affirm that the rights and remedies of Assignee with respect to the security interest in the Collateral made and generated hereby are more fully set forth in the Agreements, the terms and provision of which are hereby incorporated herein by reference as if fully set forth herein.
