

NOW, THEREFORE, pursuant to the Contribution Agreement, Assignor does hereby sell, assign, transfer, convey and deliver to Assignee its entire right, title and interest in, to and under the Trademarks and all associated goodwill and rights related thereto, including, without limitation, all rights, interests, claims and demands recoverable in law or equity, that Assignor has or may have in profits and damages for past, present and future infringements of the Trademarks and the right to compromise, sue for and collect such profits and damages, and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and any official of any country or countries foreign to the United States of America, whose duty it is to issue trademarks on applications as aforesaid, to issue all trademarks based on the Trademarks set forth in Appendix T-1 to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


