OF  
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement (the "Trademark Security Agreement") was executed by BearingPoint, Inc. 
Pledgor has requested and the Secured Party has agreed to release the Trademark Registrations and Applications and discharge the Trademark Security Agreement.
